CONDENSED MINUTES OF

DIRECTOR'S MEETING OCTOBER 11th

A special meeting of the Board of Directors was held in the Wesley Peacock House in San Antonio October 11, 1986, with the following Directors present: Mike Vlieger '62, Doug Ham '54, Pat Boscamp '60, Mark Hawkins '65, Robert Lynn Powell '66, Rudy Johnson '53, Jim Ingram '56, Real Ransom '58, Tom Colbath '48, Bill Morse '56, Ben Sutton '42, Wayne Spivey '51, Gary Bacon '49, and Julian Weslow '52. Also attending: Jim Heath '56 and John Viles '28. Alumni President Mike Vlieger presided.

Highlights of the meeting included the following: Rudy Johnson (Treasurer) reported a balance of \$2,475.70 in the Association's bank account.---Chief Executive Officer Doug Ham outlined a proposed plan to develop and expand the goals and aspirations of the Association and Alumni.---Annual dues, beginning in 1987, were adopted as follows: Honorary Members (none); Regular Members \$50.00 per year; Lifetime Members \$500.00. Dues for Associate Members \$30.00 year year; Lifetime Membership \$300.00. ---Bill Morse '54 of Houston has the distinction of being the first to take out a Life Membership.---Doug Ham proposed that the Association compile and print a new up-to-date Directory, and President Vlieger was instructed to obtain pricing information from Eddie Wise '69, who is in the printing business.---Responsibility for publishing the NEWSLETTER beginning with the next issue was placed with Pat Boscamp '60, using an entirely new and attractive format. Individual Alumni will be encouraged to provide feature articles and news of interest to the general membership. ---Although a formal vote was not taken, it was generally agreed that the proposed re-establishing of PMA was not feasible and would no longer be sponsored by the Board of Directors. Rudy Johnson stated that he would continue to work on the project as an individual.---In order to devote full time to this project Rudy resigned as Treasurer, but will continue to be active as a Director---Next meeting of the Board is scheduled for January 24, 1987.

NEWS OF THE PEACOCK FAMILY

Col. Wesley Peacock, Jr. was 90 years old last August and is still going strong! Col. Donald will be 80 in December. He has been honored twice since the Academy ceased operation. On February 14, 1982, he was awarded the Salvation Army Distinguished Service medal by the General of this worldwide organization. On November 6, 1982, in a ceremony at Camp Mabry in Austin, he was installed in the Texas National Guard Hall of Honor. The Citation reads "In recognition of his Selfless Dedication to Duty, Outstanding Achievements, and Service to the people of Texas." You will remember that he was Chief of Staff of the State Guard for several years.

Miss Dorothy Peacock has moved in to a condo with her sister, Mrs. Margaret Peacock Hames. She deeded her home adjacent to the campus to the Salvation Army, the house to be demolished and the corner lot converted to a parking lot for the Citadel Chapel across the street on the corner of West Ashby and Wilson Blvd, directly across the street from the Wesley Peacock House (formerly the Academy Headquarters Building).

The Alumni Headquarters has been moved to the Wesley Peacock House, 2811 West Ashby Place, San Antonio, Texas 78201, where all meetings of the Board of Directors are held, and where it will be more convenient for the Association President, Mike Vlieger, who lives in San Antonio. 1st Vice President Pat Boscamp, Editor of the KADET NEWSLETTER, also lives in San Antonio. The Wesley Peacock House will be remembered as the Headquarters building of the Academy. It was the original school building when Prof. Wesley Peacock, Sr. founded PMA in 1894, and has now been designated a historical landmark by the Texas Historical Commission. 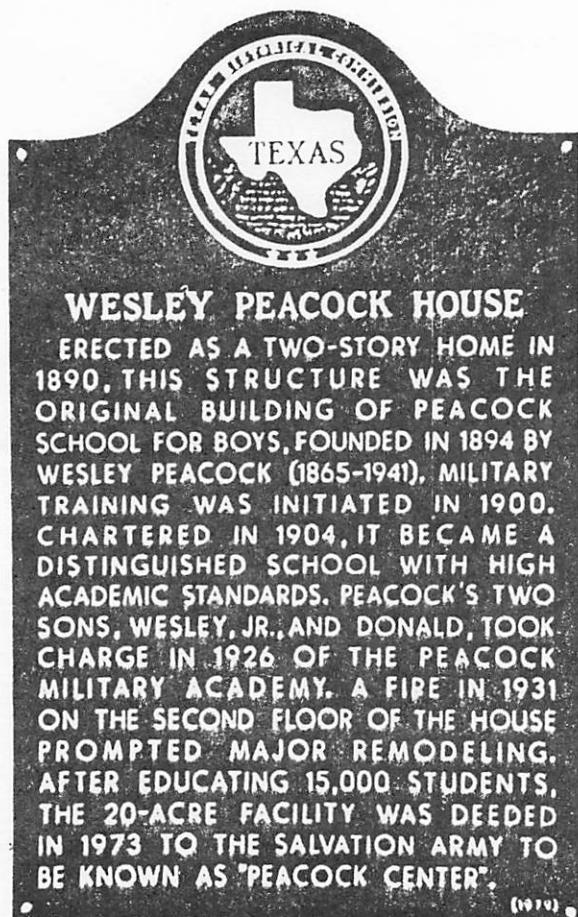

PEACOCK ACADEMY RECORDS, INC.

Peacock Academy Records, Inc. is a non-profit corporation Chartered by the State of Texas by the Peacock Family. Its purpose is to maintain the Wesley Peacock House as the address of record of the PMA Alumni Association, to house the archives and memorabilia of the Peacock Military Academy, and to preserve and make available the academic records of the 15,000 plus cadets who attended the Academy during the years 1894 until June, 1973. As the original school building when the "Peacock School for Boys" was founded by Prof. Wesley Peacock, Sr. in 1894, it has been designated an historical landmark by the Texas Historical Commission. It served as the Academy Headquarters for many years prior to the close of the school in June of 1973.

Contributors to the Trust Fund should make their donation checks payable to "Peacock Academy Records, Inc." and mail to 2811 West Ashby, San Antonio, TX 78201. Acknowledgement of your Donation will be sent to you and your name added to the list of Donors to be permanently displayed in the Wesley Peacock House, which is also the Headquarters of the PMA Alumni Association.

OFFER TO ALUMNI ASSOCIATION BY
A.M. PATE, JR. '38, and SEBERT PATE '45

Extract from letter to Col. Donald Peacock dated October 7, 1986.

"You mentioned several months ago you and Wesley had put \$15,000.00 of your own money in the Trust Fund for the 'Peacock Academy Records, Inc.' At that time you said none of the Alumni had made any direct contributions.

"Sebert and I would like to make the Alumni Association an offer through you. We would like to raise another \$15,000.00 through you and the Alumni. We would offer to give \$1.00 for every \$2.00 raised from the Alumni, payable to the Peacock Academy Records, Inc. We will put a limit on our gift of \$5,000.00. In other words if the Alumni raises \$10,000.00, we would give \$5,000.00. If the Alumni Association raises \$3,000.00, we would give \$1,500.00 to the Fund. This offer is good through the balance of 1986 and all of 1987."
